A. Ordinance 2024-02, Open Accessory Structures – 2nd Reading and Public Hearing

City Attorney Tom Trask read Ordinance 2024-02 by title only:

ORDINANCE 2024-02

**AN ORDINANCE OF THE CITY OF MADEIRA BEACH, FLORIDA,
AMENDING DIVISION 4 (ACCESSORY STRUCTURES) OF ARTICLE VI
(SUPPLEMENTARY DISTRICT REGULATIONS) OF CHAPTER 110**

(ZONING) OF THE CITY'S LAND DEVELOPMENT CODE TO PROVIDE FOR APPLICABILITY; TO PROVIDE DEFINITIONS; TO REQUIRE BUILDING PERMITS FOR ACCESSORY STRUCTURES AND PROVIDE FOR REGULATION OF CHICKENS; TO PROVIDE FOR MAINTENANCE OF ACCESSORY STRUCTURES; AMEND THE SETBACKS FOR REAR YARD ACCESSORY STRUCTURES ON LOTS ON WATER IN R-1 ZONING DISTRICT; AMEND THE SETBACKS FOR REAR YARD ACCESSORY STRUCTURES ON LOTS ON WATER IN R-2 ZONING DISTRICT; AMEND THE SETBACKS FOR ACCESSORY STRUCTURES IN C-4 ZONING DISTRICT AND ADD ALLOWANCES FOR FEDERAL AND STATE REGULATED STRUCTURES; ADD QUANTITY TO MAXIMUM SIZE OF ACCESSORY STRUCTURES IN R-1, R-2, AND R-3 ZONING DISTRICTS; AMEND THE MAXIMUM SIZE FOR ENCLOSED AND OPEN ACCESSORY STRUCTURES FOR SINGLE-FAMILY USE, DUPLEX AND MULTIFAMILY USE, AND TEMPORARY LODGING USE; ADD QUANTITY TO MAXIMUM SIZE OF ACCESSORY STRUCTURES IN C-1, C-2, C-3, AND C-4 ZONING DISTRICTS; ADD A SECTION TO ADDRESS CONSTRUCTION TRAILERS; ADD A SECTION TO ADDRESS OUTDOOR KITCHENS; PROVIDING FOR CONFLICT, SEVERABILITY AND CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

City Attorney Trask said the ordinance was first read on May 8, 2024, and there have been no changes.

Vice Mayor Brooks opened to public comment. There were no public comments.

- Commissioner Kerr said the percentage of the total lot size was not updated in the memo.

Commissioner Kerr motioned to adopt Ordinance 2024-02, Open Accessory Structures, after 2nd Reading and Public Hearing. Commissioner McGeehen seconded the motion.

A. Gulf Beaches Public Library FY 2025 Budget

City Manager Robin Gomez explained the item and said there is a slight increase in the City's portion. He recommended approval of the Gulf Beaches Public Library FY 2025 budget.

Vice Mayor Brooks opened to public comment. There were no public comments.

- Commissioner Kerr complimented Helen "Happy" Price for doing a good job. He thought the increase was related to the resident population.
- Ms. Price said Madeira Beach had an increase in population, and three of the towns had a decrease in population.
- Commissioner McGeehen said they have done a great job.

Commissioner McGeehen motioned to approve the Gulf Beaches Public Library FY 2025 Budget. Commissioner Kerr seconded the motion.

B. Fire – IAFF Local 4966 Collective Bargaining Agreement FY 24 – FY 27

The City Manager explained the item and mentioned that the Union had approved the agreement 15-0. He asked for approval of the three-year agreement.

Vice Mayor Brooks opened to public comment. There were no public comments.

- Commissioner Kerr said it has been a big issue ever since he has been on the Board. He fully endorses bringing the paygrade up to an average of the county. He is proud of what they do and supports it 100%.
- Commissioner McGeehen agreed with Commissioner Kerr and said it is a great investment.
- Vice Mayor Brooks agreed and said she loves the Fire Department.

Commissioner Kerr motioned to approve the Fire – IAFF Local 4966 Collective Bargaining Agreement for FY 24 – FY 27. Commissioner McGeehen seconded the motion.

C. Gulf Blvd Undergrounding City Easement Approval

The City Manager explained that their approval would allow them to continue with the Gulf Blvd. Utility Undergrounding Project.

- Public Works Director Megan Wepfer said it is the final stage to complete the project, which is set to start the week after the Fourth of July. They do not have all the equipment from Duke Energy, but they have enough to get started.

Vice Mayor Brooks opened to public comment. There were no public comments.

Commissioner Kerr motioned to approve the three Gulf Blvd. Undergrounding City Easements. Commissioner McGeehen seconded the motion.

D. Concession Stand and Enclosed Building Schematic Proposal

The City Manager explained the item and the purpose. The total cost is just over \$53,000.00.

- Recreation Director Jay Hatch said that upon approval, they would choose some dates for public meetings to get the public involved. After they choose the design, they will know the anticipated cost and explore grant opportunities.
- Commissioner Kerr said he supports the project.
- Commissioner McGeehen said he also supports it. With Director Hatch's help, a lot of people come to the City.
- Vice Mayor Brooks said she looks forward to the workshops.

Commissioner McGeehen motioned to approve the Concession Stand and Enclosed Building Schematic Proposal. Commissioner Kerr seconded the motion.

E. City Manager Employment Agreement – 2nd Amendment

The City Manager explained the item. He thanked the Commission for their continued support.

Vice Mayor Brooks opened to public comment. There were no public comments.

- Commissioner Kerr said Mr. Gomez brings a lot of expertise and professionalism to the job, along with the history of his experience. He looks forward to four more years.
- Commissioner McGeehen agreed with Commissioner Kerr and supported it 100%.
- Vice Mayor Brooks agreed and looks forward to another four years.

Commissioner Kerr motioned to approve the City Manager Employment Agreement, Second Amendment, through December 31, 2028. Commissioner McGeehen seconded the motion.

F. Human Resources, Compensation, & Classification Study – Approve Consulting Agreement with RSC Insurance Brokerage, Inc. dba Risk Strategies Company (Gehring Group)

The City Manager explained the item. He asked for approval to enter into an agreement with the Gehring Group to perform a salary study and to look at the Human Resources processes for \$37,640.00.

Vice Mayor Brooks opened to public comment. There were no public comments.

- Commissioner Kerr said at first, he was against it, but after seeing the 2019 report and

hearing Jerry Cantrell's presentation, he thought it needed to be done.

- Commissioner McGeehen said the Gehring Group is charging \$37,640.00 instead of \$27,640.00, \$10,000 of which is for looking at each job description. He did not think the City needed to spend \$10,000.00 when the Department Heads were already informing their employees of their job descriptions. He would be willing to compromise on the \$27,640.00.
- Vice Mayor Brooks said if they do not do the whole study this time, then they would be halfway doing it again. If they do the complete study, it will help the Civil Service to complete the employee handbook. She thought they needed to do both.
- The City Manager said it is good to have a professional outside the organization determine positions are appropriately doing what they should be doing.

Commissioner Kerr motioned to approve the Human Resources, Compensation, & Classification Study Consulting Agreement with RSC Insurance Brokerage, Inc. dba Risk Strategies Company (Gehring Group) not to exceed \$37,640.00. Commissioner McGeehen seconded the motion.

The City Attorney read provisions from the City Charter and the Rules of Procedure stating that actions requiring a vote require three affirmative votes for passage. If a motion for a final decision fails to achieve three affirmative votes, it will be postponed and continued to the next scheduled regular or special meeting.

The Federal Judge in the Southern District of Florida found the Bill to be unconstitutional. They do not have to file Form 6, only Form 1 on the electronic Financial Disclosure Management System at the Commission on Ethics.
